The right is reserved to charge for overdue boats at a rate of \$80.00 per hour or part thereof that they may be late in returning.

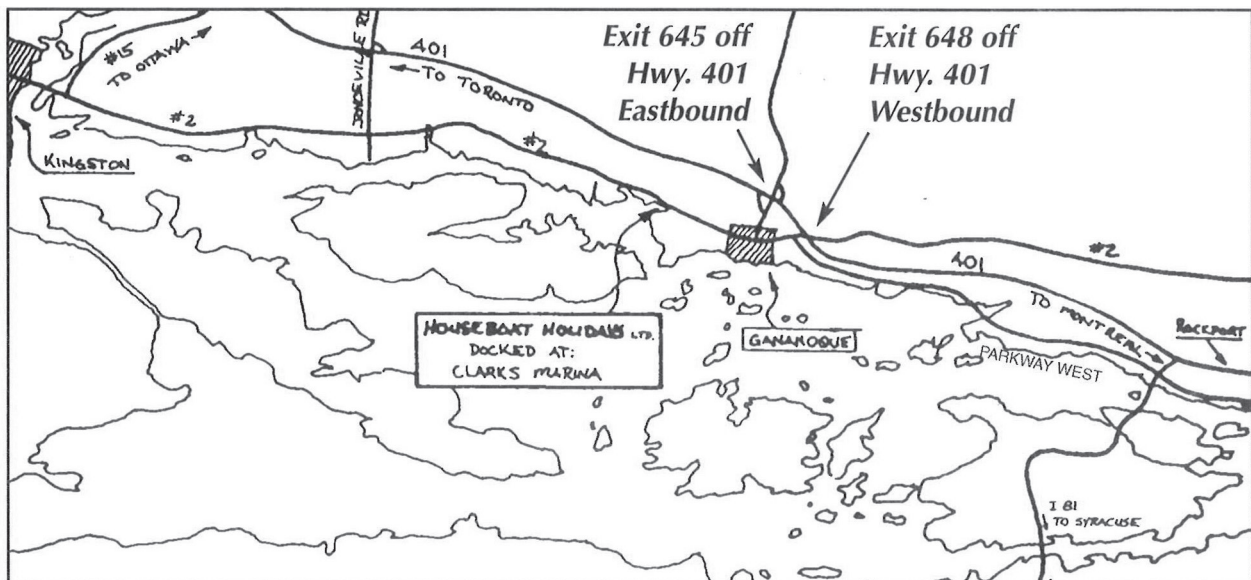
PLEASE NOTE: There Will Be No Refunds For Unused Portion of Agreed Upon Rental Period.

DEPOSIT - A Deposit of \$400.00 per reservation is required and will be RETAINED AS SECURITY DEPOSIT for the duration of the cruise as a guarantee of payment for loss of equipment or damage to the craft. Deposit will be refunded, less 20% cancellation fee, if notice is received at least 45 days prior to departure date. Any cancellation received less than 45 days prior to departure will be refunded, less 20% cancellation fee, if accommodation can be re-booked.

OUR RESPONSIBILITY AFTER A RESERVATION IS CONFIRMED - If a client arrives at Gananoque to take possession of a boat and the craft is not ready, then:

- (1) If the boat can be made ready for the following day, we will pay for one night's accommodation in a neighbourhood motel or equivalent, for the client's party. The total rental fee due will be reduced by the equivalent of one day's rent on a pro rata basis: or,
- (2) If it becomes apparent that there will be a delay of more than one day in preparation of the boat, then we will refund the deposit and any rent which may have been paid by the client, or will make whatever adjustment as shall be mutually acceptable. We will not accept liability for any other loss or damage due to failure to provide a boat as arranged.

INSURANCE COVERAGE TO A LIMIT OF \$2,000,000.00
SUBJECT TO A \$200.00 DEDUCTIBLE CLAUSE

I have read and agree to BOTH the TERMS AND CONDITIONS OF RENTAL and to the INSURANCE COVERAGE (as described in this agreement). I understand that the Security Deposit, less any charges incurred for fuel or damages, will be mailed to me on the following business day after the boat is returned.

HOUSEBOAT HOLIDAYS LTD. shall, at its own expense, maintain on its behalf (and on behalf of the Charterer); protection and indemnity insurance with respect to third parties for death or injury to persons or property but such COVERAGE SHALL NOT EXTEND TO ANY PERSONAL INJURY, BODILY INJURY, DEATH OR PROPERTY DAMAGE, TO THE CHARTERER, HIS CREW, HIS GUESTS OR TO ANY INSTRUCTOR OR PAID MASTER ON THE HOUSEBOAT. IN THE EVENT THAT ANY ACT OF NEGLIGENCE BY THE CHARTERER SHALL CANCEL ANY INSURANCE HEREINAFTER PROVIDED FOR, THE CHARTERER SHALL PAY TO HOUSEBOAT HOLIDAYS LTD. ALL LOSSES AND INDEMNIFY HOUSEBOAT HOLIDAYS LTD. AGAINST ALL CLAIMS AND DEMANDS WHICH WOULD OTHERWISE HAVE BEEN COVERED BY SUCH INSURANCE. SUCH ACTS OF NEGLIGENCE WILL INCLUDE OPERATING THE HOUSEBOAT UNDER THE INFLUENCE OF INTOXICATING LIQUOR OR ANY DRUG. HOUSEBOAT HOLIDAYS LTD. SHALL NOT BE RESPONSIBLE OR LIABLE FOR ANY PERSONAL INJURY, DEATH OR PROPERTY DAMAGE TO THE CHARTERER, HIS CREW, OR GUESTS OR TO ANY INSTRUCTOR OR PAID MASTER ON THE HOUSEBOAT, CAUSED BY THEIR OWN ACTIONS OR OMISSIONS. The terms of the foregoing insurance will only apply in the Charterer's interest if immediate written notice of any occurrence likely to give rise to loss is given to HOUSEBOAT HOLIDAYS LTD. **This insurance is in effect provided the following items are agreed to.** The Client:

- (1) Agrees to pay the deductible amount of \$200.00 associated with a legal settlement.
- (2) Shall make no admission of liability, either before or after an occurrence for which either he or HOUSEBOAT HOLIDAYS LTD. may be liable.
- (3) Shall not interfere in any negotiations by HOUSEBOAT HOLIDAYS LTD. insurance company for the settlement or any legal proceedings in respect of any occurrence for which either he or HOUSEBOAT HOLIDAYS LTD. may be liable.
- (4) Shall aid in securing information and/or evidence if so required by HOUSEBOAT HOLIDAYS LTD. or their insurance company.
- (5) Shall co-operate with HOUSEBOAT HOLIDAYS LTD. or their insurance company in the defence of any claim or suit or in the appeal from any judgment arising therefrom.
- (6) **Shall report any accident involving the houseboat to HOUSEBOAT HOLIDAYS LTD. verbally within 24 hours of occurrence, in writing at time of returning the boat from rental.**

With my signature on the first page of this agreement, I AGREE THAT THE ABOVE STIPULATIONS FORM PART OF THE TERMS AND CONDITIONS OF RENTAL.
